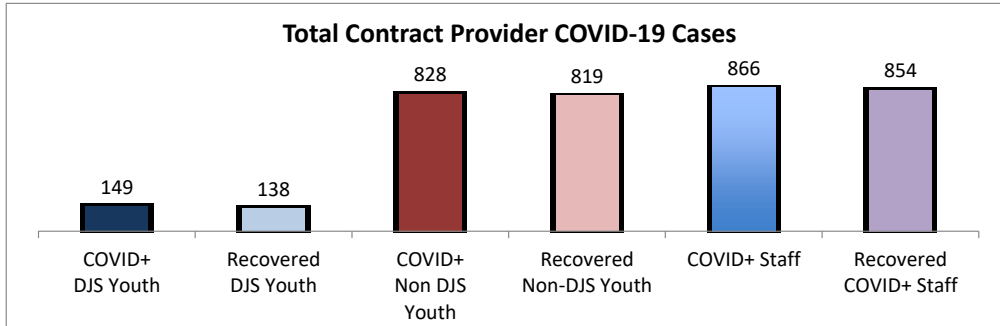


Overall COVID19 Cases To Date, February 6, 2023
