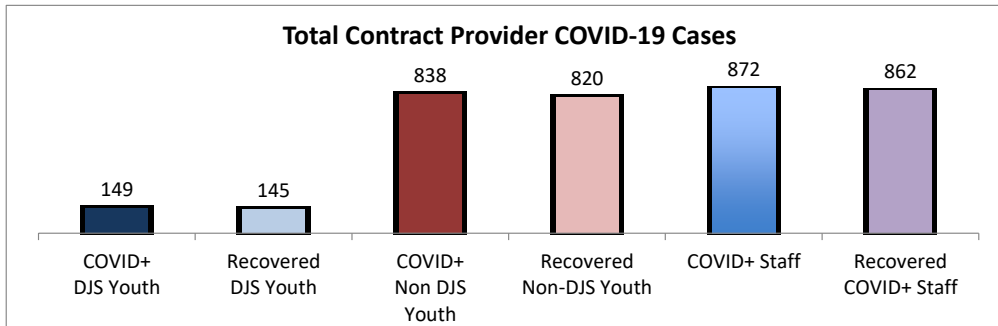


**Overall COVID19 Cases To Date, February 14, 2023**
