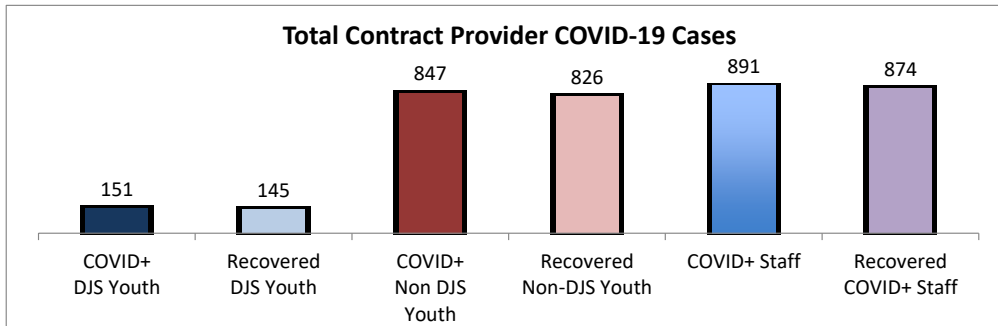


**Overall COVID19 Cases To Date, March 2, 2023**
