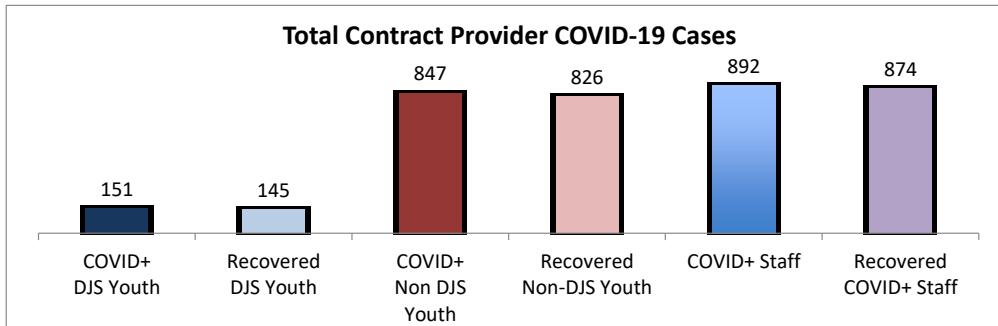


**Overall COVID19 Cases To Date, March 6, 2023**
