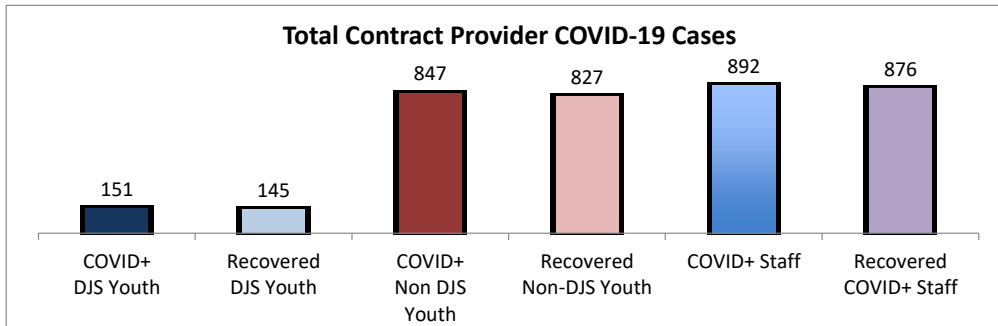


Overall COVID19 Cases To Date, March 8, 2023
