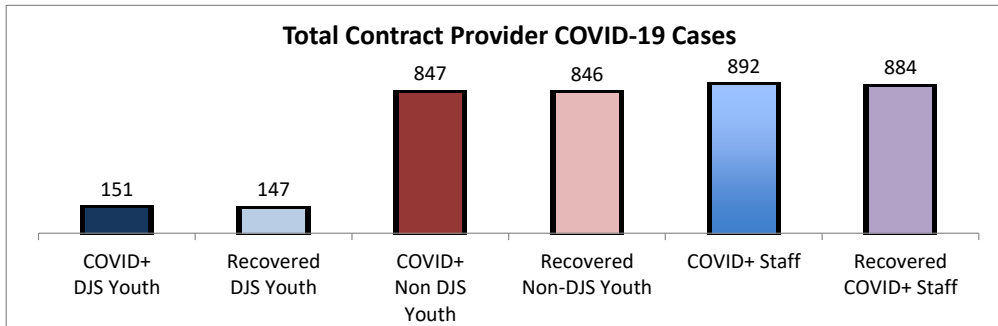


Overall COVID19 Cases To Date, March 9, 2023
