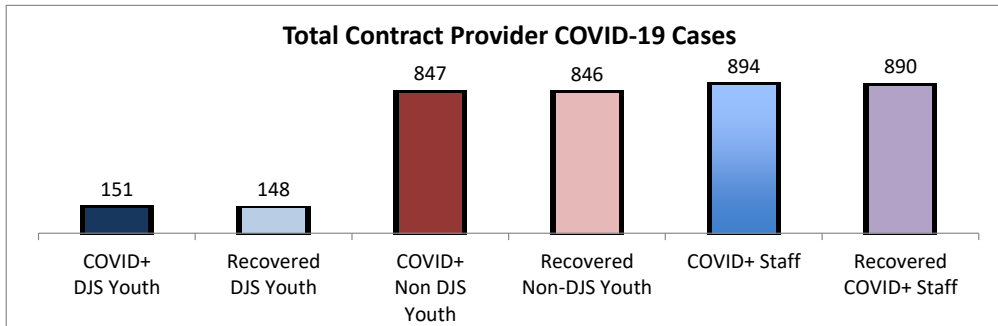


**Overall COVID19 Cases To Date, March 22, 2023**
