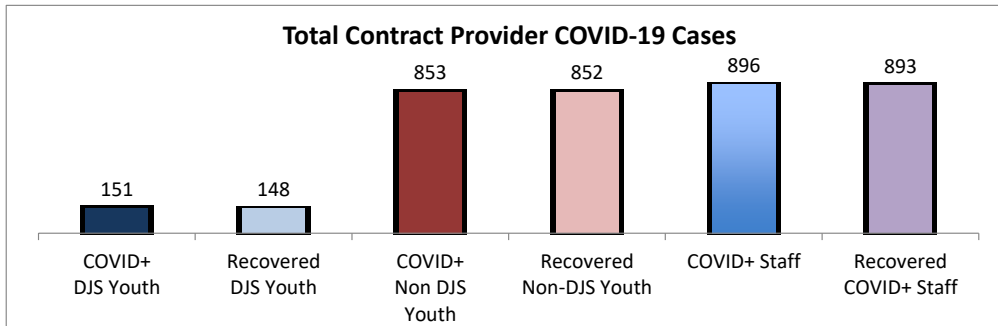


Overall COVID19 Cases To Date, May 4, 2023
