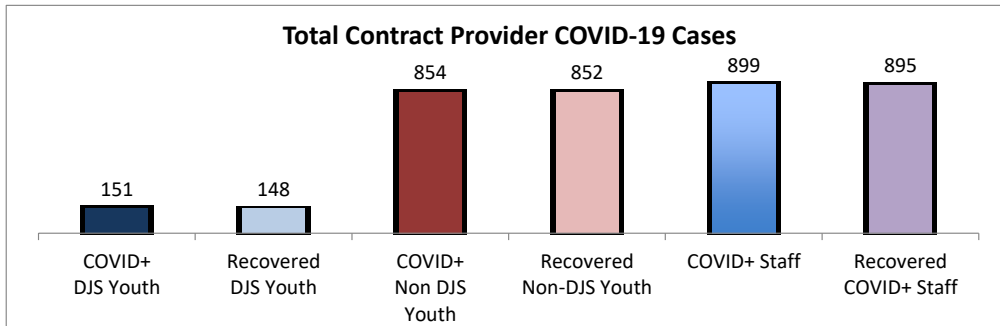


Overall COVID19 Cases To Date, August 22, 2023
