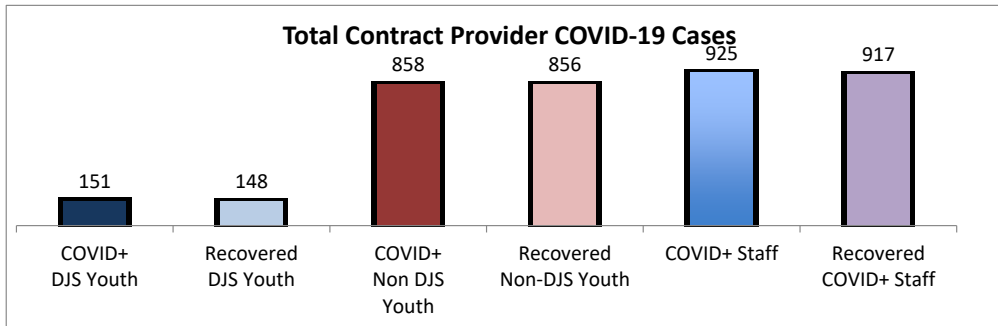


Overall COVID19 Cases To Date, December 18, 2023
