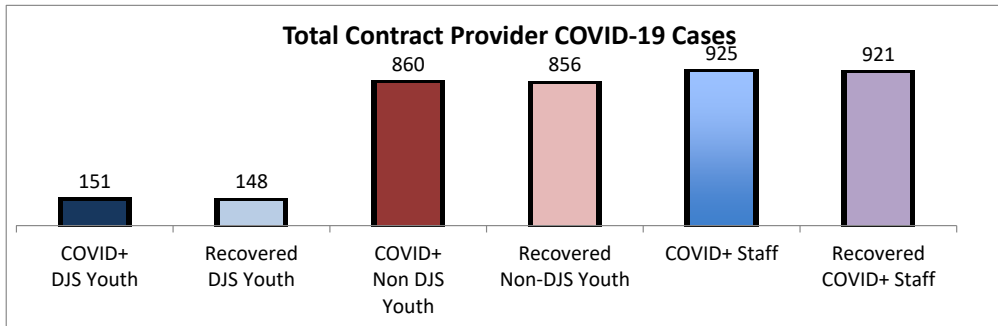


**Overall COVID19 Cases To Date, December 26, 2023**
