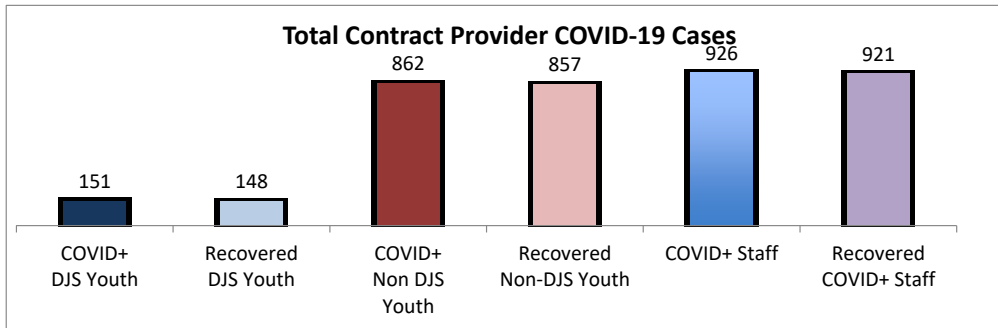


Overall COVID19 Cases To Date, January 2, 2024
