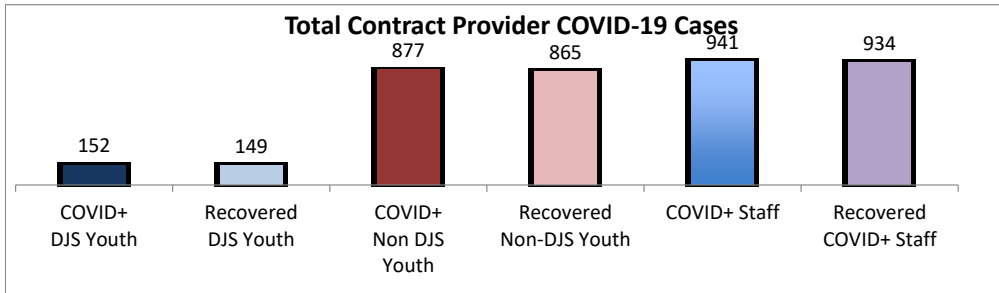


Overall COVID19 Cases To Date, February 5, 2024
