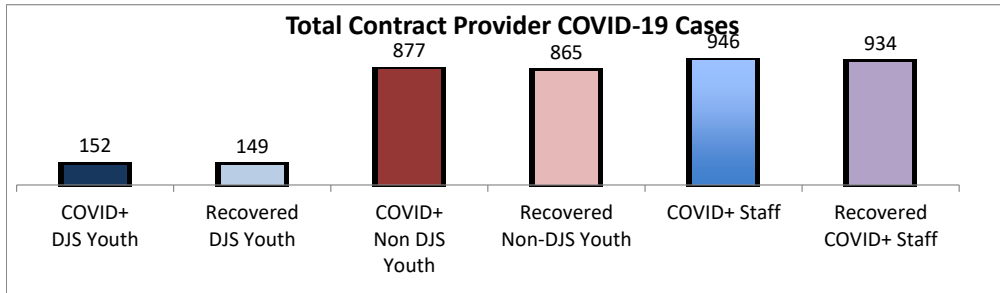


Overall COVID19 Cases To Date, February 12, 2024
