#### **Proposed mission statement:**

- Prepares students to successfully engage with their communities
- Collaborates with youth, families, communities, and other stakeholders

- Ensures the effectiveness of school-based professionals
- Utilizes innovative practices and data-driven decision making

### **The proposed Vision Statement:**

All students matter. JSEP schools facilitate individualized education that builds on students' strengths preparing them for continued success and positive engagement in their communities.

- John Irvine with support from Dr. Shane Hall facilitated the discussion on the Board Goals. The goals from the previous Board Retreat were reviewed. Grace Reusing suggested titles for each of the pre-established goals. The group agreed that a student achievement goal needs to be added to the existing goals. Superintendent Pogue and her leadership team agreed to work on that goal. That goal will be presented to the Board at a later date. The Standards Sub-Committee will work to develop goal objectives and standards. The Standards Sub-Committee will then present them to the entire board for final approval.

The proposed goals are as follows:

To promote a student-centered approach to decision-making that is informed by best practices that foster ongoing collaboration and innovation.

#### **Goal 2 – Positive School Environment**

To create an educational experience where students and educational staff feel safe and supported and are partners in their educational experience.

To establish and maintain strong partnerships with LEAs, community organizations, mentoring programs, community colleges, and the business community to promote successful student transition and outcomes.

Recruit, retain, and support JSEP teachers and staff in order to provide quality educational services and successful outcomes for JSEP students.
