

- Source of Admissions (FY 2024):
 - 95.4% of admissions were from Maryland jurisdictions. Of those from out of state, there were 4 from Washington, D.C.; 3 from Virginia; and 1 from Wisconsin.
- Average Length of Stay (ALOS) in Days:
 - For cases involving a transfer from facility to facility, the total ALOS is reflected on the statewide pages. The specific facility's page reflects only the ALOS at that particular facility.
- Pre-D Offense Category (Most Serious Offense) Trends FY 2022-2024:
 - The percentage of Crimes of Violence decreased from 33.9% to 31.7%.
 - The percentage of Felonies decreased from 28.6% to 25.2%.
 - The percentage of Misdemeanors increased from 32.1% to 33.3%.
- Average Daily Population (ADP):
 - Overall, ADP increased 40.2% between FY 2022 and FY 2024 and increased 17.8% between FY 2023 and FY 2024.
 - Overall, ADP has consistently been below capacity.

PEACE Academy opened March 4, 2024 within the WMCC as a hardware secure treatment program. Data for youth in PEACE Academy are not reflected on the WMCC page since they are not detention youth. More details on PEACE Academy can be found on page 133.





ADP BY ADMISSION TYPE, FY 2022-2024




PRE-D PLACEMENTS BY RISK LEVEL FOR YOUTH WITH A COMPLETED DRAI*, FY 2022-2024
