**High Supervision** 1 face to face contact per week, and 1 bi weekly guardian contact /  
**Moderate Supervision** 2 face to face contacts per month, and 1 guardian contact per month  
**Low supervision** 1 face to face contact every 90 days, and 1 monthly phone contact with youth and guardian  
**Intensive Level Contact Requirements** 2 face to face contacts per week, and 1 bi weekly guardian contact
