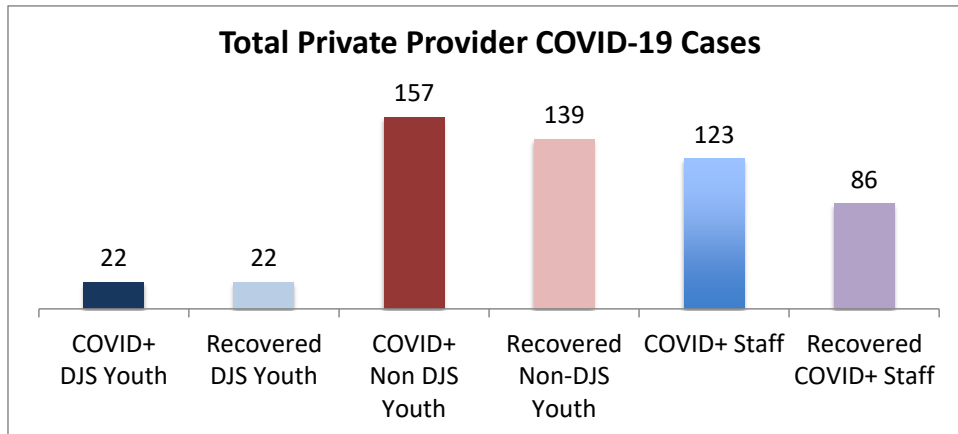


**Overall COVID19 Cases To Date, July 10, 2020**
