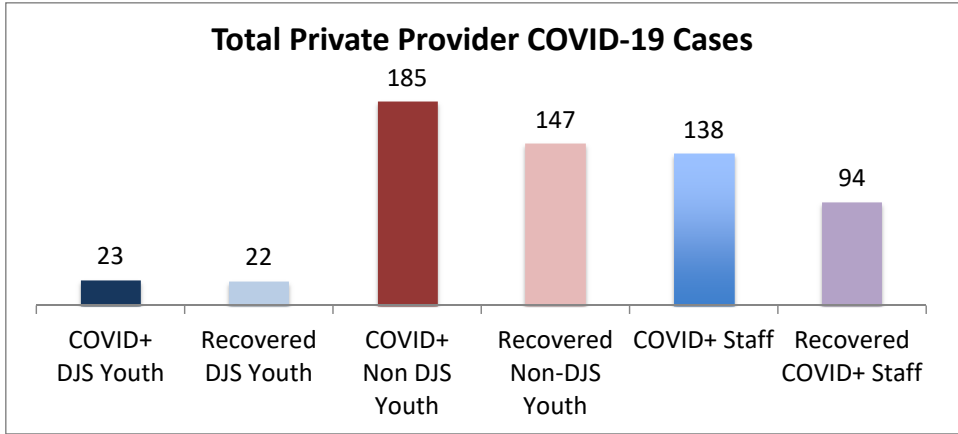




Overall COVID19 Cases To Date, July 20, 2020
