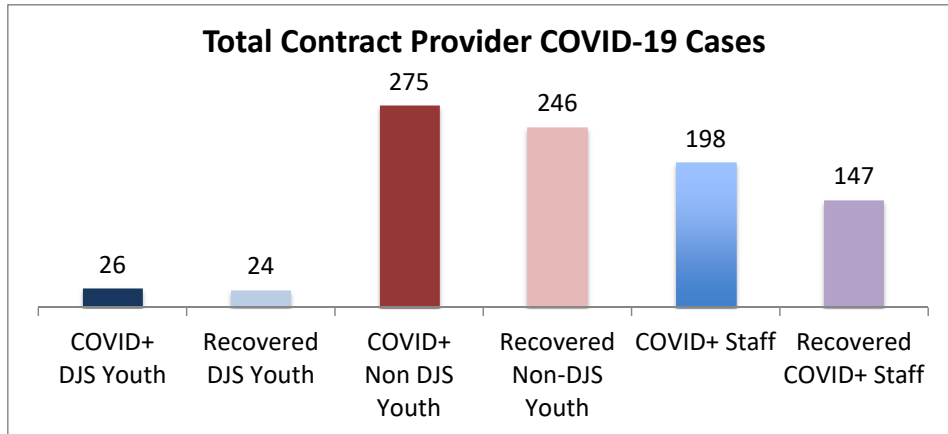




Overall COVID19 Cases To Date, August 17, 2020
