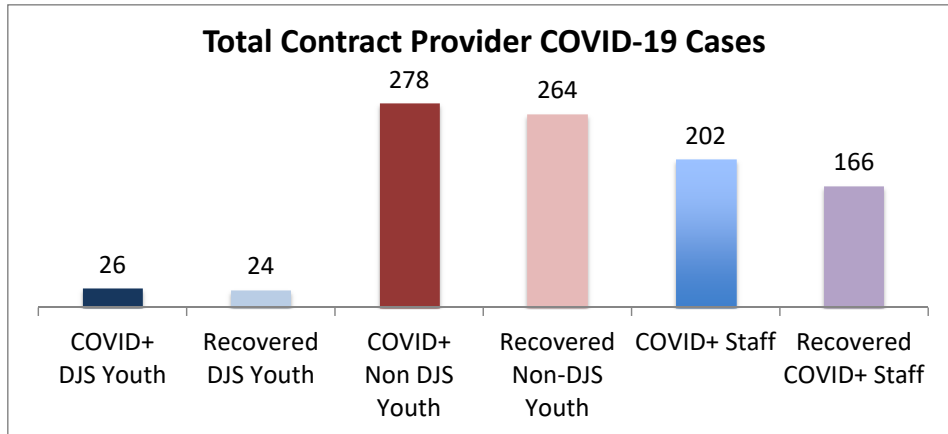


Overall COVID19 Cases To Date, August 19, 2020
