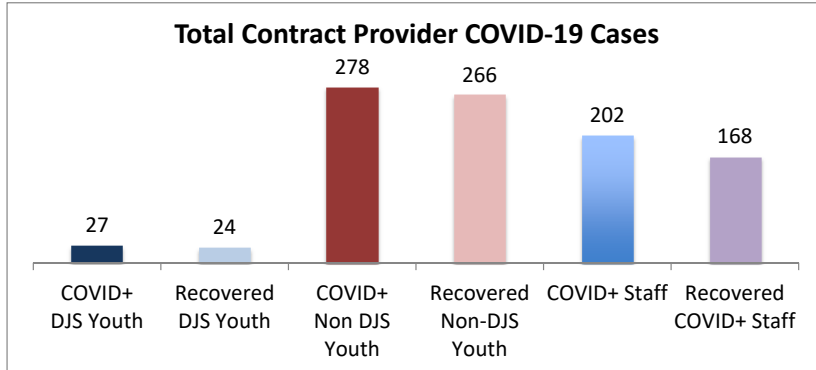


Overall COVID19 Cases To Date, August 24, 2020
