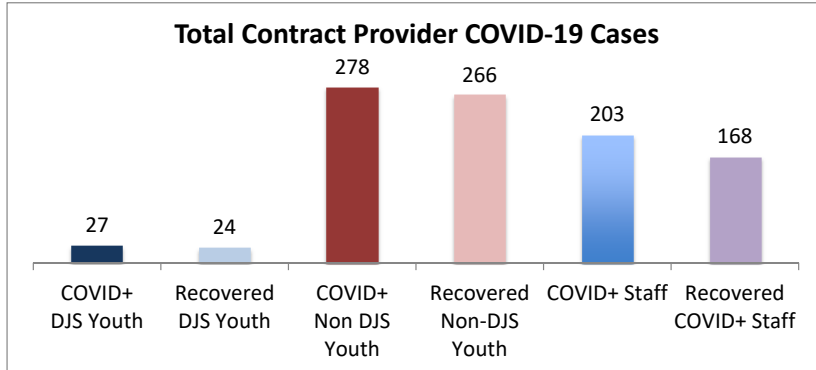


Overall COVID19 Cases To Date, August 25, 2020
