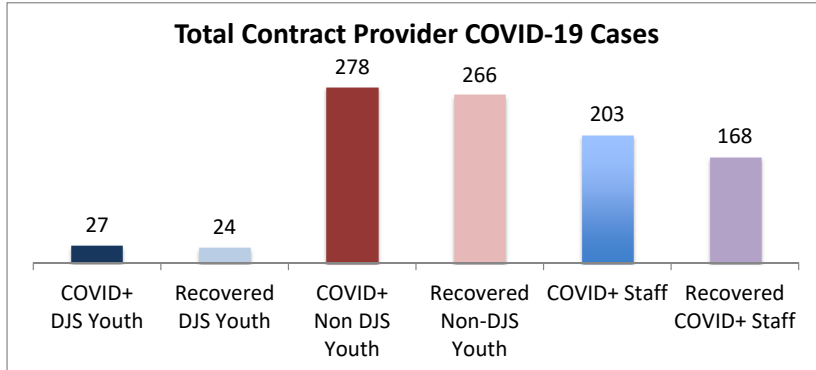


**Overall COVID19 Cases To Date, August 27, 2020**
