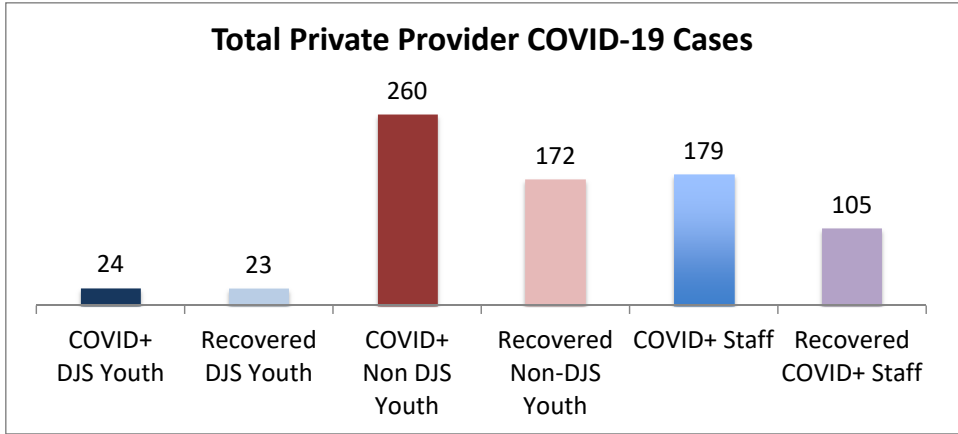




Overall COVID19 Cases To Date, August 4, 2020
