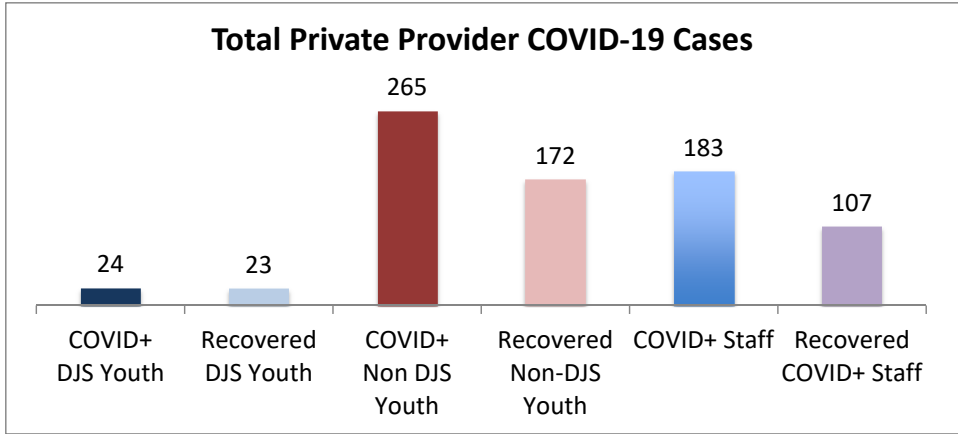




Overall COVID19 Cases To Date, August 5, 2020
