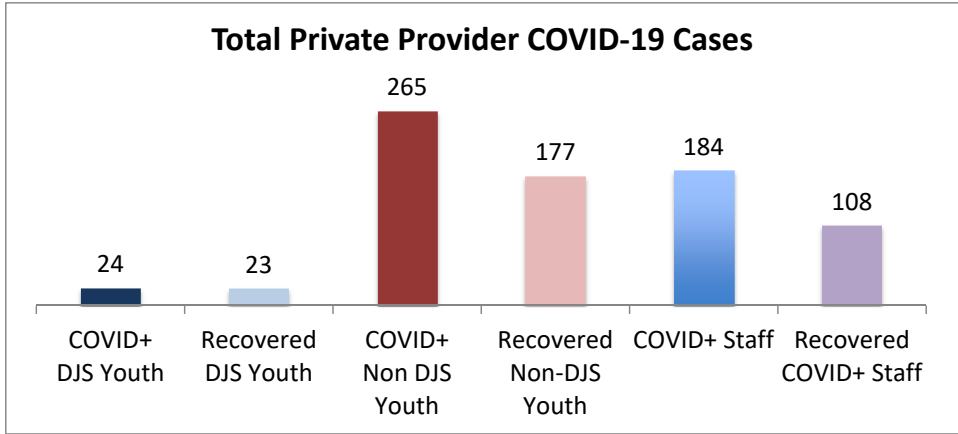




Overall COVID19 Cases To Date, August 6, 2020
