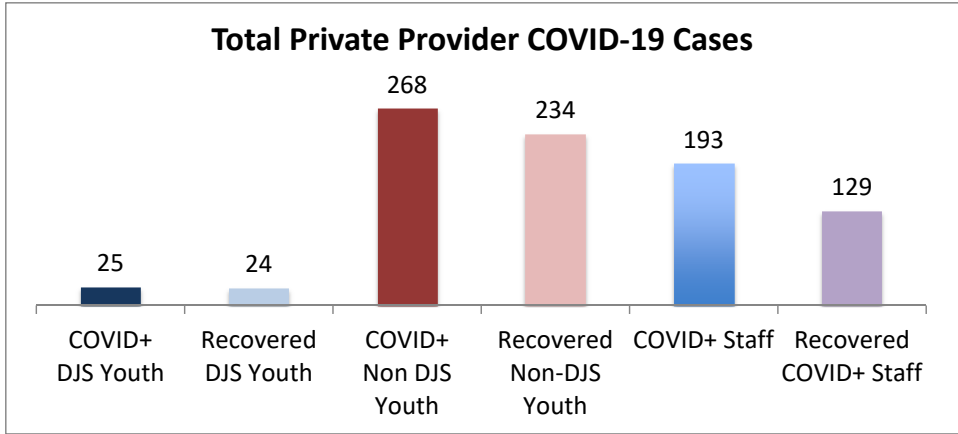




**Overall COVID19 Cases To Date, August 11, 2020**
