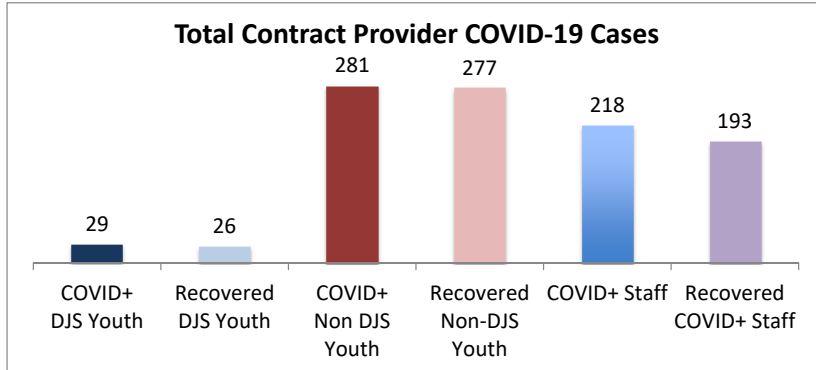


Overall COVID19 Cases To Date, September 22, 2020
