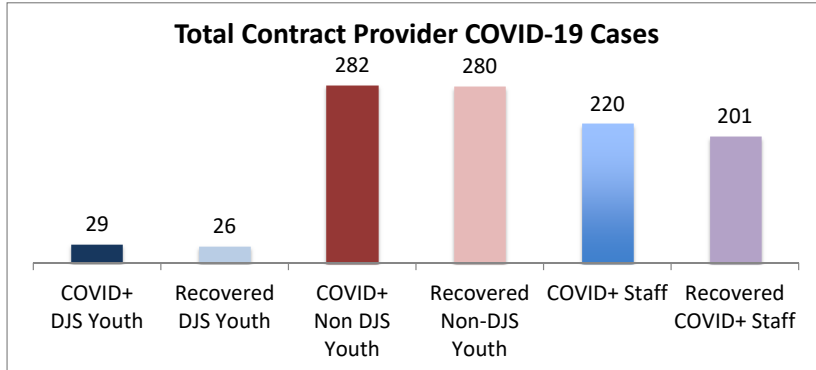


Overall COVID19 Cases To Date, October 1, 2020
