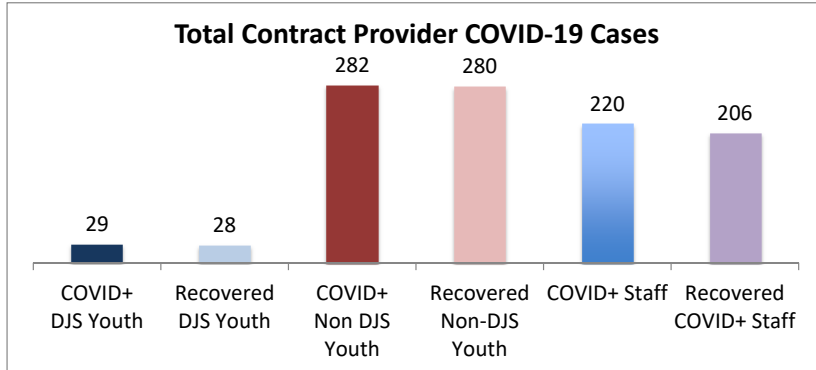


Overall COVID19 Cases To Date, October 8, 2020
