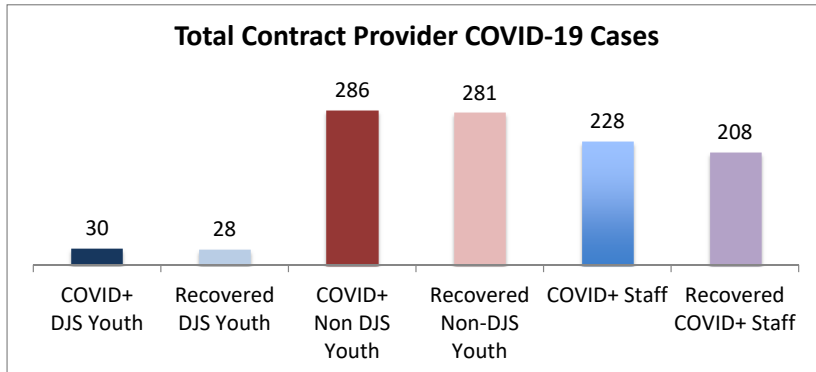


Overall COVID19 Cases To Date, October 19, 2020
