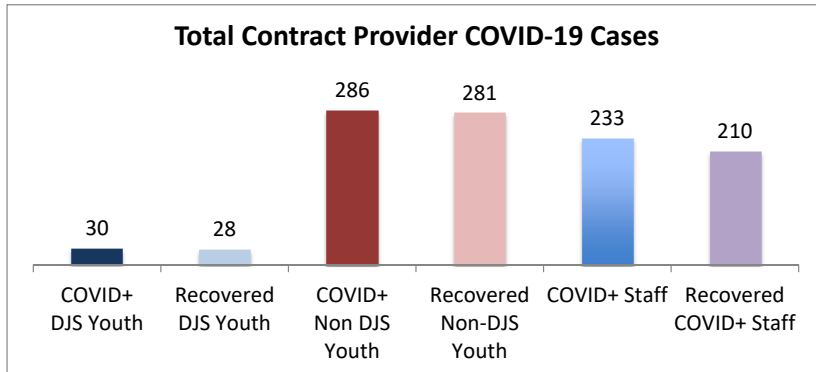


**Overall COVID19 Cases To Date, October 26, 2020**
