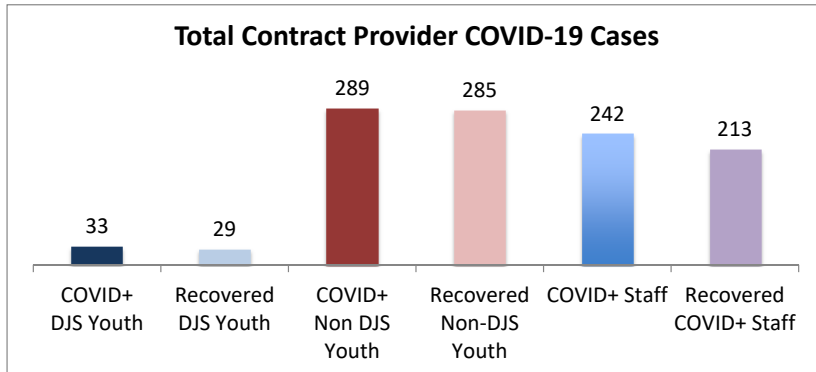


Overall COVID19 Cases To Date, October 29, 2020
