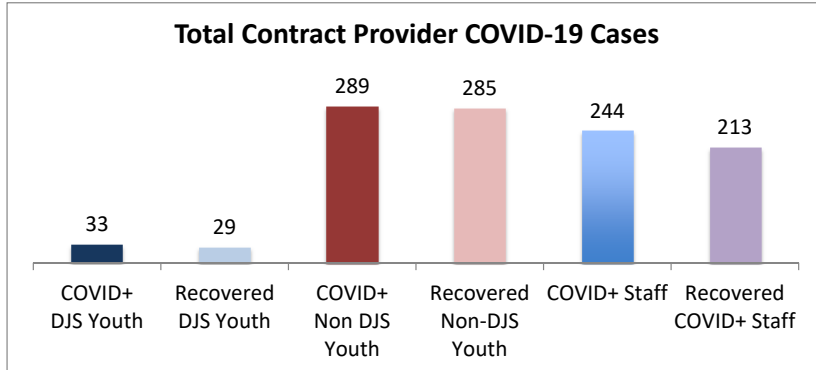


Overall COVID19 Cases To Date, October 30, 2020
