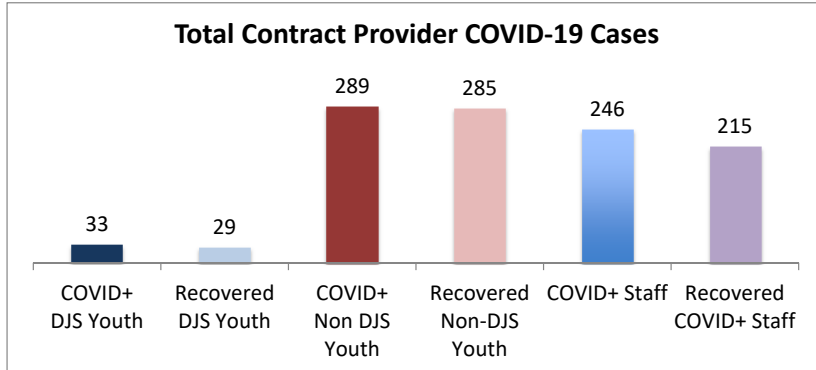


Overall COVID19 Cases To Date, November 2, 2020
