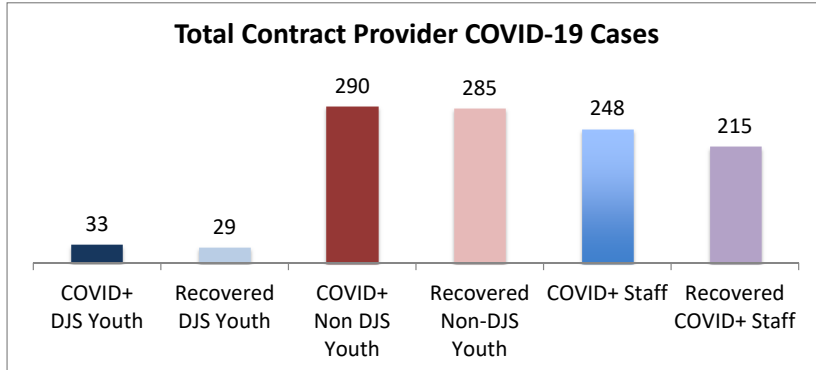


**Overall COVID19 Cases To Date, November 5, 2020**
