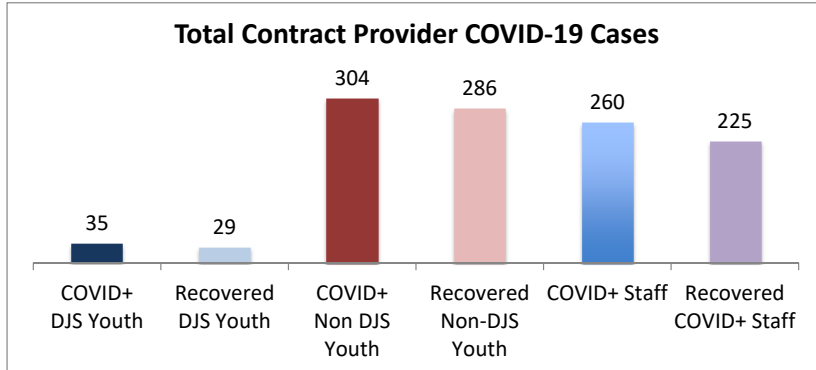


Overall COVID19 Cases To Date, November 12, 2020
