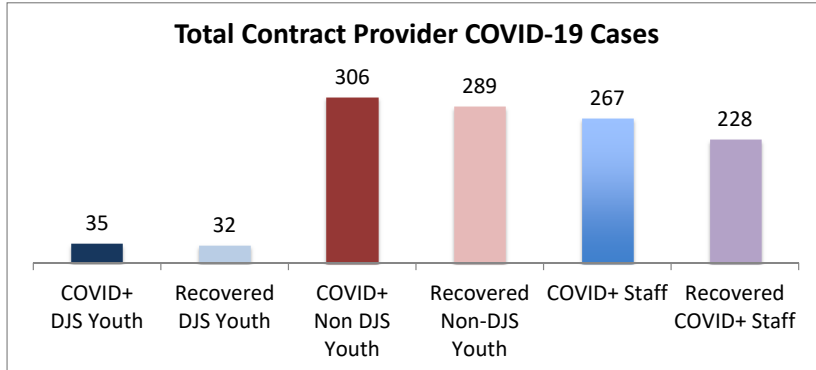


**Overall COVID19 Cases To Date, November 16, 2020**
