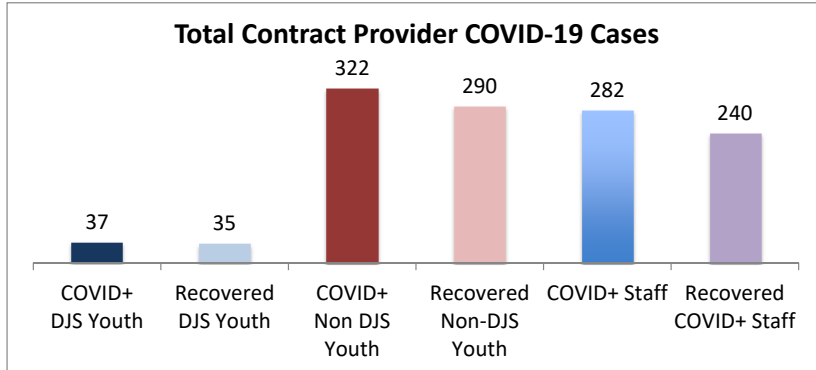


Overall COVID19 Cases To Date, November 23, 2020
