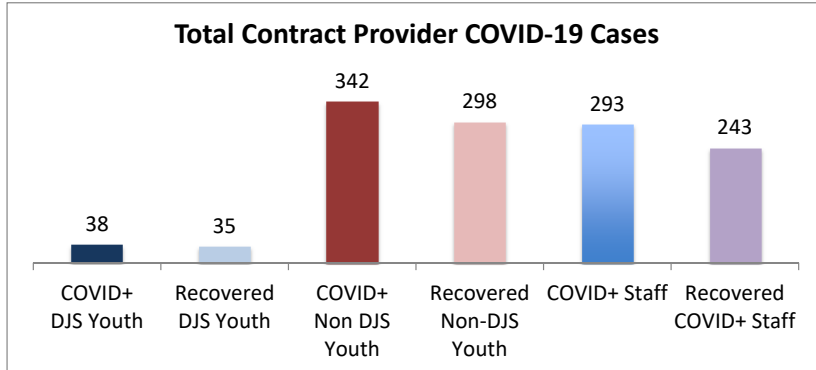


Overall COVID19 Cases To Date, November 30, 2020
