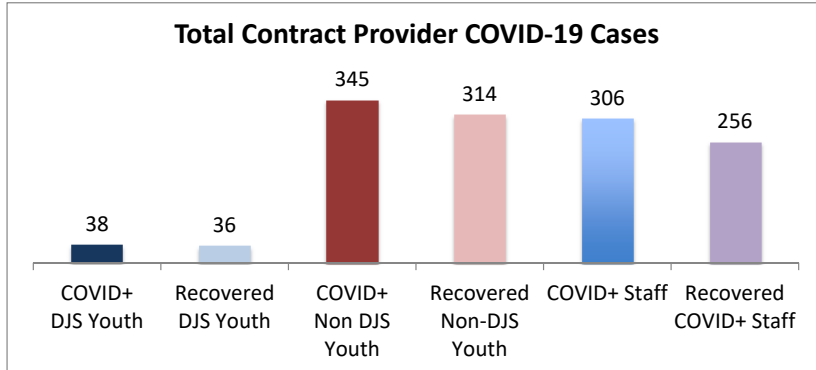


**Overall COVID19 Cases To Date, December 3, 2020**
