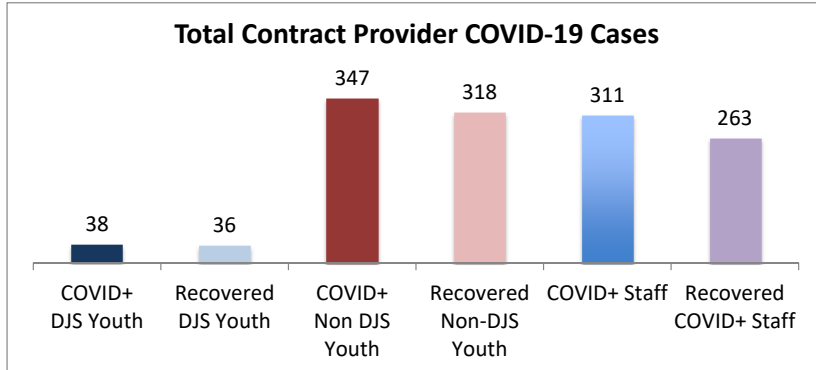


Overall COVID19 Cases To Date, December 7, 2020
