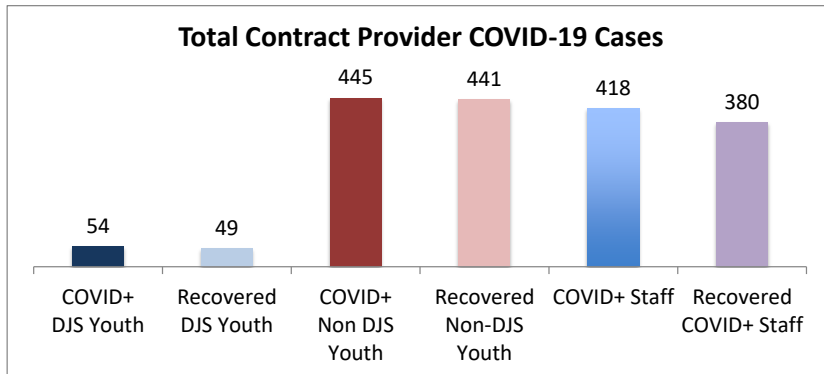


**Overall COVID19 Cases To Date, March 1, 2021**
