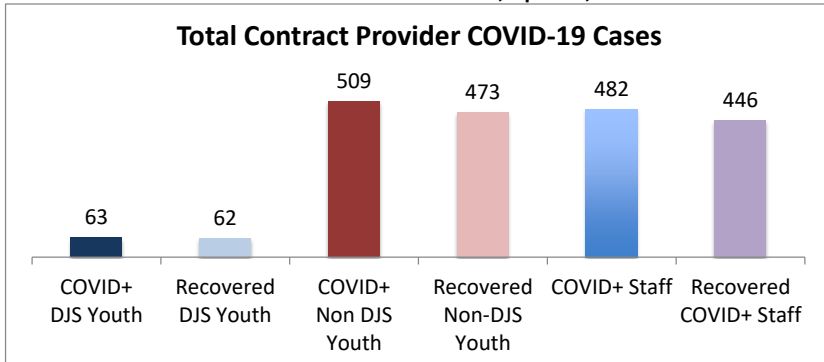


**Overall COVID19 Cases To Date, April 27, 2021**
