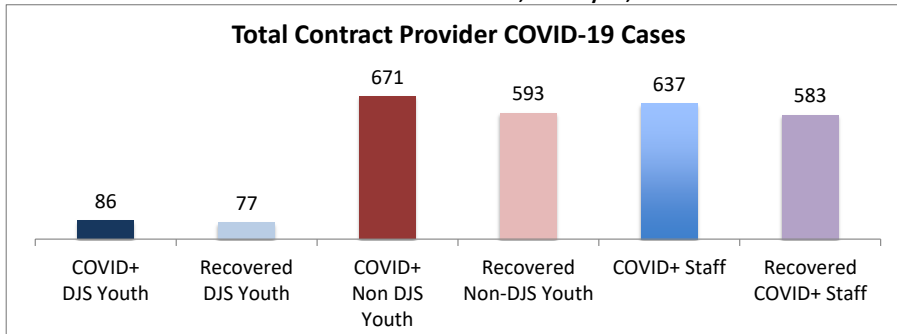


Overall COVID19 Cases To Date, January 11, 2022
