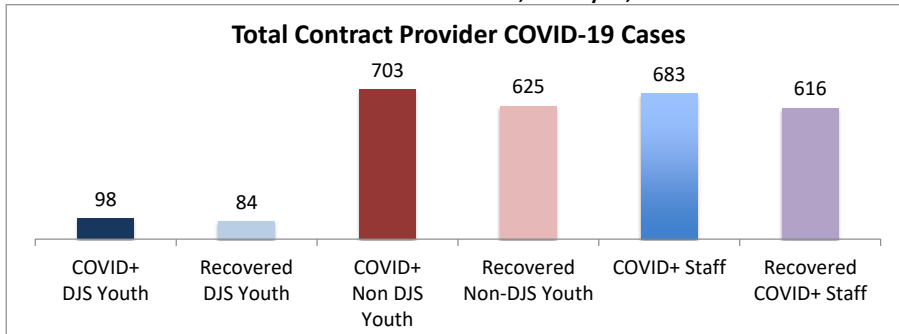


Overall COVID19 Cases To Date, January 26, 2022
