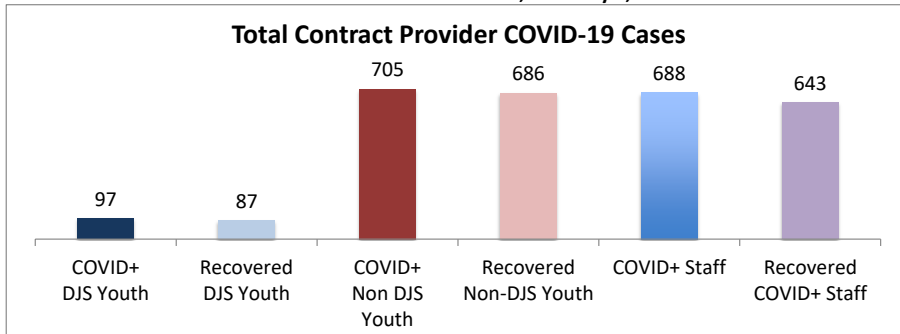


**Overall COVID19 Cases To Date, February 3, 2022**
