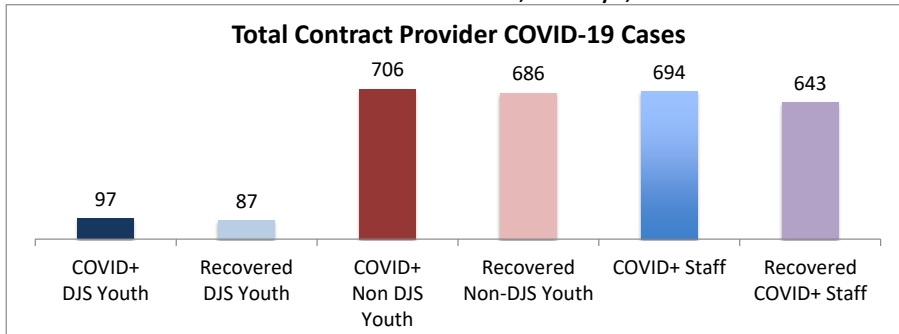


Overall COVID19 Cases To Date, February 4, 2022
