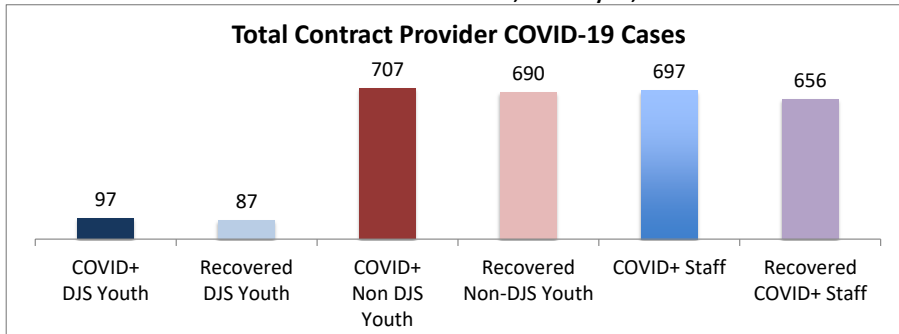


**Overall COVID19 Cases To Date, February 11, 2022**
